Ten Years On: Vertical Agreements under Article 81 424

The European Commission is currently reviewing its policy on vertical agreements. The rules on hardcore restrictions can be clarified, particularly in the area of limited distribution where sufficient inter-brand competition should be viewed as more relevant to the assessment. In addition, the analysis of exclusivity agreements by dominant firms is not consistent with the European Commission’s recently adopted policy on exclusionary abuse under art.82.
