## Justice Eady libel judge highest profile legal figure

- Fiona Shackleton retains top spot as highest profile lawyer
- Credit crunch litigation so far fails to reveal any new star lawyers

Justice Eady, the senior libel judge, is this year's most high profile member of the legal profession, featuring in 334 press articles over the past 12 months, reveals research carried out by Sweet & Maxwell, the leading legal information provider.<sup>1</sup> (See table of results below)

Justice Eady has attracted the attention of the media for what some commentators see as controversial judgements restricting press freedoms. According to Sweet & Maxwell, a Thomson Reuters business, press coverage of Justice Eady accelerated in the wake of his ruling on the privacy case brought by Formula One chief Max Mosley against the News of the World.

Other high profile cases Justice Eady has ruled on over the past year include Madonna's privacy case against the Daily Mail, actress Sienna Miller's privacy case against photographic agency Big Pictures and footballer Michael Owen's libel action against the Daily Express.

### Leading divorce lawyers continue to attract column inches

Fiona Shackleton has retained the top spot as the UK's highest profile solicitor this year. The leading divorce lawyer has featured in 247 national and regional press articles over the past 12 months, after representing Madonna in her divorce from director Guy Ritchie. Divorce lawyers dominate the rankings of the highest profile lawyers.

Guy Ritchie's divorce lawyer, Lady Helen Ward, also features in this year's Top 10 as a new entry, taking seventh place. Family lawyer Ward has been cited in the press 70 times in the last year and is reported to have acted for Formula One Chief Bernie Ecclestone in his divorce from Slavica Ecclestone and Caroline Spencer in her divorce from Earl Spencer.

Divorce lawyer Raymond Tooth has also entered the Top 10 this year in fifth place. Tooth acted for Ingrid Myerson, the former wife of City fund manager Bryan Myerson who failed in his attempt to renegotiate their divorce settlement after seeing his net worth plunge as a result of the financial crisis.

## Human rights lawyer Clive Stafford Smith enters Top Three

According to Sweet & Maxwell's research human rights lawyers have tended to dominate press coverage of the legal profession in recent years. However, the only human rights lawyer to feature in the list of Top 10 most high profile lawyers this year is Clive Stafford Smith.

Stafford Smith, who is acting for the former Guantanamo Bay detainee Binyam Mohamed who alleges that he was tortured with the knowledge of UK intelligence services, has featured in 174 press articles over the past year.

Human rights lawyers Phil Shiner and Imran Khan who have featured in the Top 10 for the past two years running have fallen to 15<sup>th</sup> and 24<sup>th</sup> place respectively this year.

Recent research by Sweet & Maxwell has revealed that the number of reported cases making use of Human Rights Act arguments fell by 14% between 2007 and 2008 although the use of Human Rights arguments is now being used in a far greater variety of cases.

## Corporate solicitors still outside Top 10 despite credit crunch litigation

Despite the credit crunch triggering an increase in litigation the work of corporate lawyers continues to receive comparatively little attention in the national and regional print media.

Bruce Buck, who is the second most high profile solicitor for the second year running is the only corporate lawyer in this year's Top 10, with 167 press mentions. However, Sweet & Maxwell points out that almost all of these articles refer to his role as Chairman of Chelsea FC rather than his work as a Partner at Skadden, one of the world's highest grossing law firms.

Aside from Bruce Buck, the highest profile corporate lawyer this year is Nigel Boardman, Partner at Slaughter and May who has featured in 21 press articles over the past 12 months. Boardman has received press coverage for his role in advising the Government on the recapitalisation of RBS, Lloyds TSB's takeover of HBOS and the collapse of the Icelandic banks.

From the world of barristers David Pannick QC (acting for hedge funds in the Northern Rock litigation against the Government) and Cherie Booth QC (acting for pension funds against RBS in shareholder litigation) receive more attention from the media placing them as the second and fourth highest profile barristers.

Alina Lourie, Business Unit Director at Sweet & Maxwell, comments: "The legal profession plays such a central role in some of the most contentious areas of public debate. Whilst the public's attention is instinctively captured by legal stories involving the rich and famous, it is always interesting to see how other legal topics such as human rights, shareholder rights and press freedom move in and out of the media's attention."
