Highlights:

The only major reconsolidations planned for 2014 will be for the Case Law Digest component of the Abridgment, and the Index to Canadian Legal Literature.

We plan to reissue only one title of the Case Law Digests: Labour and **Employment.** We expect the reissue to comprise 30 volumes.

The Labour and Employment reissue will involve a significant enhancement of the title. The reissue will involve both the addition of new material and the upgrading of a large number of classification-only case digests. The value of the Labour and Employment title will be significantly enhanced by this process.

While we endeavour to provide you with the most accurate prices and publishing dates, it is impossible at this time to state with absolute certainty the number of volumes, month of publication, and price. All prices are estimates and may change. We can, however, provide you with an outline of the 2014 program as it is currently planned, and we will keep you informed of any variation as the year unfolds.
